2013 Reunion a Success in Spite of Rain

Dinner was a delicious buffet, the setting was ideal, and everyone had a wonderful time.

Hosts John Paul Thrasher, Grady Thrasher and Celestea Sharp provided an excellent schedule of events, highlighted by a Saturday morning bus tour of several sites historically significant to the Thrasher family. What comfort -- the bus would have fit right in on a cross-country tour.

Highlights of the tour included a talk in the Salem Methodist Church by Mr. Hale, a caretaker of the church for generations, and lunch at Kumquat Mae's bakery and café, the treat of Grady Thrasher and Kathy Prescott.

Almost as fascinating as the historical highlights was watching the very skilled bus driver maneuver that huge bus down narrow country lanes and through turns that were never meant for such a vehicle. Warren Thrasher, Jr. and his brother John Paul Thrasher provided exterior "extra eyes" for the driver as she negotiated turn-arounds and sideways slopes.

John Paul and Celestea served as narrators for the tour and Celestea had put together a very informative handout for each of us. Saturday afternoon's program included presentations by Bill H. Thrasher on the Find-a-Grave website and a computer software program for image viewing and manipulating and by Jim Moule on Thrashers in the California Gold Rush. Montana Thrasher shared a video from America's Most Wanted; it was a reenactment of his father's suspected smuggling activities and his disappearance, and Celestea Sharp showed one on the search for John Thrasher's residence in Oconee County, which they hoped would provide clues to the location of his grave.

The program was followed by the TFA business meeting. Current officers were reelected, with a working committee to assist President John E. Thrasher because he had asked for help due to the stress of Eleanor Thrasher's illness. John and Eleanor were sorely missed at the reunion; they have been the heart of past reunions and it wasn't the same without them. Other regulars Dale and Trudy Thrasher were not able to be there due to health issues and were also missed. In other business, Robert (Buddy) Thrasher presented the treasurer's report and long-time newsletter editor Barbara Eger passed the baton to incoming editor Sue Q. Thrasher. Barbara will finish out the year with Sue taking over the task early in 2014.

The grand finale of the evening was a trip to Ciné, a downtown theatre, where we were treated to a private showing of Grady Thrasher's documentary, "The World's Smallest Airport." The film was followed by a buffet in the theater's private dining room, again the treat of Grady and Kathy.

After visiting over Sunday morning breakfast, everyone headed home -- it was still raining but people's faces were smiling!

Descendants of Thomas “Jack - Jason” Thrasher

You may wish to refer to the December 2012 and April 2013 issues of the Thrasher Newsletter to refresh your memory about this family's genealogy which we are presenting in several parts. This is the third part and follows the descendants of Benjamin & Sarah White Thrasher's grandson, (son of Benedict Randal Thrasher) Thomas “Jack - Jason” Thrasher & his wife Kessiah Bailey.

Two members of the Thrasher Family Association, Paul Wesley Thrasher and John Anthony “Tony” Thrasher, as well as Luther Leroy Thrasher participated in the TFA's DNA program and were “matches” in this family line. Their contribution of information for inclusion in this genealogy was very valuable and appreciated.

John E. Thrasher III

Descendants of Thomas "Jack - Jayson" Thrasher

Generation No. 1

1. THOMAS "JACK - JAYSON"³ THRASHER (*BENEDICT RANDAL², BENJAMIN¹*) was born September 19, 1831 in Franklin County, Georgia, and died Aft. January 12, 1904 in Conns Creek, Cherokee County, Georgia. He married KESSIAH BAILEY February 19, 1852 in Franklin County, Georgia, daughter of JOHN BAILEY and NANCY. She was born February 1830 in South Carolina, and died Aft. 1900 in Conns Creek, Cherokee County, Georgia.

Notes for THOMAS "JACK - JAYSON" THRASHER:

Thomas "Jack - Jayson" Thrasher is found in the U. S. Census:

1850 - Franklin County, Georgia. His father listed under the name of Randal Thresher. He is listed as Jayson.

1860 - Hartwell, Hart County, GA

1870 - Shoal Creek, District, Hart County, GA. P. O: Parker's Store

1880 - Cherokee County, GA (Cross Roads district 1000, Ed 26, sheet 19)

1900 - Conn's Creek, Cherokee County, GA. In this Census, Thomas Jack and family are living next door to Thomas E. (b. 1870) and Mamie Thrasher Sr. and their family. This Thomas E. is the son of Thomas Jack-Jayson Thrasher.

In the 1900 Census, Thomas' daughter Kissiah Emilis Thrasher is living with him and five grandsons.

Thomas' occupation is listed as "farmer." He is able to read and write.

The marriage of Thomas Jack Thrasher and Kessiah Bailey is found in the Franklin County, Georgia marriage records. He is listed as, John Thrasher. (Remember, Jack is a nick name for John!)

He is also listed as "Jayson" Thrasher in the 1850 Census. In a family tradition he was called "Jack."

Found in the U. S. Civil War Soldier Records and Profile:

Name: T. J. Thrasher

Residence: Hart County, Georgia

Rank at: Private

State served: Georgia

Survived the War? Yes

Service record: Enlisted in Company H, 15th Infantry Regiment, (Benning's Brigade) Georgia Volunteers on 15 July 1861. Mustered out (retired) on 17 July 1864. He was wounded in the Battle of Malvern Hill in Virginia, 2 June 1864. (Sources : Roster of Confederate Soldiers of Georgia 1861 - 1865)

Thomas J. applied for Pensions from 1888 through 1904. He may have applied each year, but most records show a two year application. He applied in Bartow, Forsyth, Dawson and Cherokee Counties. The pension records are available and found in "Georgia, Confederate Pension Applications, 1879 - 1960." When applying, in some years he sometimes signed the requests as Thomas J. Thrasher and some years as T. J. Thrasher.

Among these papers is the report from the office of Dr. H. P. Clark - Physicians * and * Surgeon - office in the Houser House

"Dawsonville, Ga. March 12, 1888

This is to certify that we have this day examined Thomas J. Thrasher and find that he is wounded in the following manner. He has been struck with a Shell at the rist joint of the left arm. The shell ranging up to the Elbow fracturing ulna bone of the forearm and doing enough injury to both the elbow and wrist-joints to render them permanently Stiff or Andi ---- when the arm is extended to the fullest extent. It hangs down, the forearm extending across the breast and he has not the power to extend it any farther. He has also lost the Sight of the left Eye almost entirely. He cannot distinguish any printed Letters. He cannot distinguish any object at any distance from him. We will Say that his left-Arm is rendered Substantially and essentially useless to perform any manuel labor. We deem him incompetent and practically incompetent to perform the manuel activities of life. His eye is permanently injured and if it was not for the sight of his right eye, he could not perform any normal labor that would require any traveling about.

Signed H. P. Clark, M D

Sworn to and subscribed before me - March 12, 1888. J. S. Taylor, Ordinary"

In another sworn statement on 21 January 1897 (Dawson County, Georgia), Drs. Looper and Clark give

almost the same description with this added bit of interest: " - - - shattering the bone of the arm and permanently disabling the arm more severly ____ cannot chip with an axe or hoe - - - ."

In the Pension Applications, Thomas J. signs saying that he had been a citizen of the State (Georgia) since 19 September 1831. In one he says, 1830.

Notes for KESSIAH BAILEY:

Kessiah is listed in the 1900 Census for Conn's Creek, Cherokee County, GA as being a mother of seven children, six still alive in 1900.

Kessiah Bailey Thrasher and Basheba Bailey Thrasher are sisters.

Nancy is found in the 1860 and 1870 Census for Hart County, Georgia with her parents.

In the 1900 census she is found with her husband and two children in Bartow County, Georgia.

In 1900 Nancy and James had been married for 22 years.

She was the mother of three children, two living in 1900.

In the 1920 Census Nancy and James M. Roberson were living in Adairsville, Bartow County, Georgia.

Notes for KIZZIAH EMILIS THRASHER:

It is believed that Kissiah E. and Emilis are the same person, one listed in the 1870 Census and the other name in the 1900 Census.

In the 1900 Census, K. Emilis is living with her parents in Conn's Creek, Cherokee County, GA. She is listed as "divorced" and the five children also living there are listed as "grandsons" of Thomas and Kessiah Thrasher. The grandson's names are all "Thrasher" which indicated that perhaps there was no marriage to the father whose name is unknown.

GA. He married ELDORADO "ELLA" VICTORIA HULSEY Abt. 1888, daughter of GEORGE HULSEY and SARAH WILLIS. She was born November 12, 1866 in Dawson County, Georgia, and died May 27, 1961 in Blue Ridge, Fannin County, GA.

Notes for WILLIAM WASHINGTON THRASHER:

W. W. Thrasher, called "Bud," 11q is first found in the 1870 Census for Shoal Creek, Hart County, GA with his parents.

In the 1880 Census for Cherokee County, Georgia, he is listed with his parents, being 14 years of age.

In the 1900 Census W. W. and family are found in Civil District 10, Polk County, Tennessee.

In the 1920 Census W. W. Thrasher and family are found in Sugar Creek, Fannin County, GA.

In the 1930 Census W. W. Thrasher and family are still located in Sugar Creek, Fannin County, GA

W. W. Thrasher is able to read and write. His occupation was as a miner in 1900, but as a farmer after that.

William Thrasher is listed in the "Georgia Deaths, 1919 - 1998" as William M. Thrasher; died 05 July 1939, in Fannin Co. GA. Gender M; race W; age 73 years.

Notes for ELDORADO "ELLA" VICTORIA HULSEY:

In the 1900 Census, Ella and W. W. reported that they had been married for 11 years (Ca 1888-1889).

John Anthony Thrasher wrote: All nine of Ella V. and W. W. Thrasher's children are listed on the Cherokee rolls as Ella V. was part American Indian from the Cherokee Indian tribe.

The listing of Ella and her children can be found in "Cherokee Roots" Volume 1: Eastern Cherokee Rolls by Bob Blankenship. Official United States Government Census of the Cherokee Indian from 1817 through 1924 residing East of the Mississippi River. This is the Guion Miller Roll - 1909. The children listed are: Claud, Ethel, Etta, Flora, Lee, Myrtle, Paul, and Thomas. Ella V. is also listed there. Her son Raymond would also be eligible to be listed, but was not born until 1911. Also listed on later rolls are two grandsons, sons of Ethel Thrasher: Lester D. Thrasher and George Thrasher Vestel.

He married MAMIE ESTELLE GROVER November 24, 1892 in Cherokee County, Georgia, daughter of RAFORD GROVER and MARY SHUTLEY. She was born February 11, 1876 in Georgia, and died April 05, 1963 in Bartow County, GA.

Notes for THOMAS EUGENE THRASHER:

Thomas E. is first found in the 1880 Census for Cherokee County, GA (District 1000, Ed 26, sheet 19) with his parents. He was listed as 9 years of age. In the 1900 Census Thomas E. and his family were in Conn's Creek, Cherokee County, GA. In 1910 he is found in Glenwood, Floyd County, GA.

Thomas and Mamie were listed as "renting a home" in the 1900 Census. His father, Thomas John "Jack" Thrasher, owned the property.

In the 1920 Census, which was taken on 9 January 1920, Thomas E. and his family were living in Marietta, Cobb County, GA. Thomas died on the 20th of March, just two months later.

In the 1930 Census for Pine Grove, DeKalb County, Alabama, Mamie is listed as a widow and head of the household.

"Georgia Deaths, 1919 - 1998" lists Mamie's death as 5 April, 1963 in Bartow Co. GA.
